RELEASE FROM LIABILITY AGREEMENT

This liability release and assumption of risk is made between equine rider/owner _____
Equine rider/owner's parent/legal guardian _____ (if minor) and Chris & Jenny Lance or No Fences Horsemanship (NFH), leasee, volunteers, Live To Ride (LTR) and all divisions of NFH or LTR on this _____ day of _____ 2010. The owner, his/her heirs, assigns and legal representatives, hereby expressly agree to the following:

- 1. INSURANCE.** Owner is responsible for comprehensive insurance coverage on owner's horse, personal property and his/herself whether on owner's own property, in transport in Lance owned trailer, or property owned by the Lances, or any other property where instruction from NFH or LTR are taking place. If riding a Lance-owned horse, rider's insurance covers rider.
- 2. INHERENT RISK.** Owner/Participant understands there are inherent risks in and around equine activities. Inherent risk in equine activities means dangers are an integral part of equine activities. Under Ohio State law, an equine activity sponsor or equine professional (NFH, LTR and Chris & Jenny Lance) are not liable for injury to, or the death of a participant OR horse in equine activities resulting from the inherent risks of equine activities. Activities include, but are not limited to: bucking, rearing, biting, kicking, shying, traffic, falling or stepped on; the unpredictability of an equine's reaction to such things as medications, sounds, sudden movements, unfamiliar objects, persons or other animals, hazards, such as surface and subsurface ground conditions, collisions with other equine or objects, trailering accidents; or the potential of another participant to not maintain control over the equine or to not act within the person's ability. We are also NOT responsible for any injury or death of your horse on any property or in transit.
- 3. RELEASE OF ALL CLAIMS INCLUDING NEGLIGENCE OF NFH, LTR AND LAND OWNERS, CHRIS & JENNY LANCE.** Owner/Participant expressly assumes responsibility for ALL risks in or arising from participation in any clinics or instruction on any property including, without limitation: the risks of death, bodily injury, property damage, falls, kicks, bites, collisions with vehicles, horses or stationary objects, fire or explosion, the unavailability of emergency medical care, and/or the negligence and/or deliberate act of another person. Owner/Participant agrees to hold NFH, LTR, its officers, directors, shareholders, agents, employees, insurers, hosts, volunteers and lessors (collectively referred to as Releases, and Chris & Jenny Lance) completely harmless and not liable and releases them from all liability whatsoever and agrees NOT to sue them on account of or in connection with any claims, causes of action, injuries, damages, costs or expenses arising out of or participant's use of or presence upon the Lance's property, any other property, any facility or participant's participation in any horse activities on or not on participant's property including any trailering accidents or incidents.
- 4. REGULATIONS.** Owner/Participant agrees to abide by all rules and regulations set forth by Chris Lance, Jenny Lance, NFH, or LTR. Participant is also responsible for using protective gear, i.e. hard hat and proper boots as well as safe equipment in good condition owned by participant. Minors are required to wear a hard hat while under training of NFH or LTR or riding on the Lance property. Same holds true for any company or property-owned equipment used by participant.
- 5. ANIMAL HEALTH.** Owner/Participant's horse shall be free of infection, contagious or transmissible diseases. NFH/LTR/Jenny Lance, and Chris Lance reserve the right to refuse training or allowing a horse on any property if it is not in proper health or is deemed dangerous or undesirable. Horse owner is responsible for all veterinary expenses related to their horse due to illness, injury, or death.
- 6. NON-ASSIGNABLE AND NON-TRANSFERABLE.** This contract is non-assignable and non-transferable without written consent of NFH/LTR/Jenny Lance, and Chris Lance and is enforced and interpreted under the laws of the State of Ohio.

When NFH/LTR/Jenny Lance, and Chris Lance and Owner/Participant (and participant's parent or legal guardian, if a minor) sign this contract, it will then be binding.
